# Big Al \$500 a Day Giveaway

#### OFFICIAL SWEEPSTAKES RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

#### SWEEPSTAKES DESCRIPTION:

The Big Al \$500 a Day Giveaway Sweepstakes ("Sweepstakes") will begin on December 10, 2012 and end on December 21, 2012 ("Sweepstakes Period"). This Sweepstakes will be conducted on the air, online and via text message. Twelve (12) winners will each be awarded \$500.

#### **HOW TO ENTER:**

Listeners of WHTA-FM who are legal residents of the U.S., are 18 years of age or older, and reside within the Atlanta, GA metropolitan area will be able to take part in this Sweepstakes. There are three methods of Sweepstakes entry. To participate in the Sweepstakes, participants must use one of the following methods:

## On-Air Participation:

- During the Sweepstakes Period, listen to WHTA-FM for the on-air announcement for the 9th caller to contact the Station. Be the designated caller at 404-741-1079 after the on-air solicitation for callers has been made. WARNING: Online listeners to streamed broadcasts may experience a lag in transmissions due to buffering limitations. Sweepstakes participants should not rely on streamed broadcasts to participate in the Sweepstakes.
- Eligible callers will be awarded the Prize and will be asked to verify their contact information (e.g. name, address, phone number, and email address).
- Ten (10) winners will be determined through on-air participation.

### OR

# Online Registration:

- Participants must register online through the Station's website at www.hotspotatl.com.
- Upon entering the Sweepstakes website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, and any optional or additional contact information, as requested, to register for a chance to win.
- All Internet entries must be received by 11:59pm EST on December 20, 2012, or they will be void.

- One entry per person per day per email address during the Sweepstakes Period.
- In the event of a dispute regarding the identity of a participant's online entry, the entry will be deemed to have been made by the authorized holder of the e-mail account at the time the entry was made.
- One (1) winner will be selected by random drawing from among all eligible entries received via online registration.

# Text-To-Win Entry:

- Sweepstakes participants must text "BigAl" to 85620 when prompted by the on-air announcement. Standard text and data rates will apply.
- All text entries must be received by 11:59pm EST on December 20, 2012 or they will be void.
- One text entry per person per day during the Sweepstakes Period.
- In the event of a dispute regarding the identity of a participant's entry, the entry will be deemed to have been made by the authorized holder of the mobile account at the time the entry was made.
- One (1) winner will be selected by random drawing from among all eligible entries received via text message.
- 1. Participants may only win once during this Sweepstakes.
- 2. Winners must provide valid identification (i.e. via driver's license, passport or other government-issued photo I.D.) to claim the Prize. Identification documents must match information previously provided to the station.
- 3. All decisions made by WHTA-FM and Radio One, Inc. management regarding any aspect of this Sweepstakes are final.

#### **ELIGIBILITY RESTRICTIONS:**

- 1. The Sweepstakes is open only to legal residents of the United States residing within the Atlanta, GA metropolitan area who are 18 years of age or older at the time of Sweepstakes registration.
- Employees of WHTA-FM, Radio One, Inc. If the winner or selected entrant is unable to be contacted within thirty (30) days after being selected (e.g. drawing date), is ineligible, fails to claim a prize or fails to return completed and executed release forms and affidavits, if applicable and as required by WHTA-FM, or if the prize notification or prize is returned undeliverable, that prize will be forfeited and if time permits, at the discretion of the Sweepstakes sponsor / and or Sweepstakes administrator, an alternate entrant will be selected as the winner by random drawing from among the remaining entries.

In the event any winner is found to be in violation of these Official Rules or is otherwise determined by WHTA-FM, in its sole discretion to be ineligible, he/she will be required to forfeit prize or to reimburse the station and / or any sponsor for the stated value of a prize if such a violation is found after the prize has been used by the winner.
- 8. Winners will be instructed to come to the offices of the Station located at 101 Marietta Street, 12th Floor Atlanta, GA 30303. Winners must provide valid identification (i.e. via driver's license, passport or other government-issued photo I.D.) to claim their prize.

solicitation for callers has been made; by submitting the designated text message after the on-air announcement has been made; or by registering online at www.hotspotatl.com. After completing the registration process, qualified entrants will be eligible for a chance to win the grand prize.

- 2. There will be ten (10) on-air winners, one (1) online winner, and one (1) text winner. On December 21, 2012, the online and text winners will be selected by random drawing from among all eligible entries received.
- 3. Winners will be awarded their prize in the form of a check for \$500. On-air winners will be announced; however on-line and text winners will not be announced publicly. Online and text prize winners will be notified by phone and / or email.
- 4. All decisions made by WHTA-FM and Radio One management or any Sweepstakes Sponsor regarding any aspect of this Sweepstakes are final.
